



Subject: Adelman Part 74 license issues still to be resolved

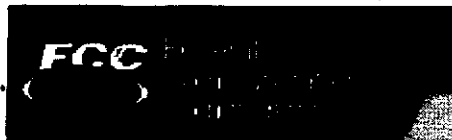
