Adelman wishes to acquire the following stations:

A plot of these "Subject Stations" follows. Please note that KGBB (FM), Edwards, CA is located far from the area which is the subject of this study and is not counted for the purposes of this study.

Paragraph 73.3555 (a)(1)(iv) states:

"In a radio market with 14 or fewer commercial and noncommercial radio stations, not more than 5 commercial radio stations in total and not more than 3 commercial stations in the same service (AM or FM); provided, however, that no person or single entity (or entities under common control) may have a cognizable interest in more than 50% of the full-power, commercial and noncommercial radio stations in such market unless the combination of stations comprises not more than one AM and one FM station."

In the Exhibit "Nearby Stations", the following nearby stations are plotted to indicate city grade service to a portion of the Subject Area. Numbers on each line correspond to that station's contour on the Nearby Stations Exhibit.


Adding the 9 Nearby Stations to the 5 Subject Stations produces a total of 14 stations in this radio market. A market of 14 services is governed by 73.3555 (a)(1)(iv) quoted above. Owning 5 stations in a marked of 14 stations is owning 35.7% of the stations in the market which is less than the 50% cap in the regulation and is allowable.


